



2019 Photo Contest Rules

Please read the rules of the Hanover Holidays Photo Contest carefully. Contact our office should you have any questions regarding these rules!

1. The submitter to the Contest must have been a passenger on a Hanover Holiday tour during 2019.
2. Any submitted picture must come from a moment captured during the Hanover Holiday tour.
3. If a picture involves other people, the submitter must have the photo subject's permission to enter the contest.
4. Any or all of the submitted photo's may be used in Hanover Holidays future marketing.
5. All of the submitted pictures, digital or otherwise, will not be returned.
6. Entries to the contest may be in either digital or a traditional photograph.
7. Entries to the contest may be made between April 1, 2019 and January 10, 2020 at 6:00 pm.
8. Any eligible Hanover Holidays' customer may submit as many pictures to the contest as they wish. Each picture constitutes one entry and chance to win the Grand Prize.
9. With each Entry, please provide your full name, address, phone number and email address.
10. Any picture submission to the contest of offensive images, or altered by robotic or computer means will be rejected.
11. All submissions will be reviewed by a minimum of 2 Hanover Holidays' employees from which a top 10 list will be derived.
12. The top 10 selected photos will be displayed on Hanover Holidays facebook page for 1 week, during which time visitors to the facebook page may each cast 1 vote for their favourite photograph.
13. Entrants names belonging to the top 10 photographs will not be revealed until after the contest closes
14. The winning submission will be awarded a Grand Prize trip for 2 on Hanover Holidays Alaska & Yukon Tour in 2020.
15. The winning submitter will be contacted on January 31, 2020.

By entering the Contest,
